Cancellation/Refund Policy

Being a small business guiding on Oregon's finest waters, cancellations affect us greatly. When WTO reserves your fishing date we allocate precious resources to that time frame. Each season affords us only small windows to maintain our company as a small family run business thriving amidst the ups and downs of NW fisheries. Cancellations received 60 days in advance of the trip date will receive a full refund. Any cancellations received less than 60 days from the trip date we will do our best to reschedule your trip if possible but last minute changes are often difficult as we are booked well in advance and deposits will not be refunded. We recommend purchasing trip insurance to protect you against unexpected changes to your travel plans. When weather and water conditions do not allow us to fish we will refund your deposit in full or reschedule your trip

to an agreed upon fishing date.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. **THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY**

PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and Water Time agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
